Dear St. Mary's Home & School Association Supporter:

The St. Mary's School Home & School Association is gearing up for the 2015-2016 school year. Besides planning the many events hosted by our organization and purchasing the supplies needed by teachers and other staff in the school, we are planning our yearly fundraisers which make possible the events and resources for students. As you know, a strong education with the appropriate resources is vital to creating responsible citizens.

This year we are planning our annual Back 2 School Fundraiser, Mrs. Claus's Cupboard, 3-Disc DVD Memories, Scrip Program, and School Carnival. In addition to these fundraisers, the annual Sponsorship Drive returns. It was implemented four years ago to streamline our efforts with supporters that see the value in supporting our school.
